- d)** The Bonar Law Common retains the right to request any person or persons to vacate the property and/or place restrictions to **any activities deemed unsatisfactory** to the safety and security of the property or personnel of the Bonar Law Common.
- e)** The Bonar Law Common shall **not be held responsible** for cancellation due to weather or other unforeseen conditions.
- f)** The actual Heritage area “house, barns, court yard, “walk through time” and museums are designated **smoke free**.
- g)** Be aware - that within **10 meters (30 feet)** of any buildings and/or seating areas, the Bonar Law Common is designated a smoke free area
